
### Hannah Sexton, NAR2 **OSANA Student Representative**

TANA Lobby Day took place on March 18th. House Bill 979, the AA Bill, recently passed out of the House subcommittee. Initially, the bill posed a significant threat to CRNA practice by proposing a shift to direct medical supervision. However, TANA successfully secured several key amendments to protect and preserve CRNA's scope of practice.


